NOTICE TO POCONO TOWNSHIP RESIDENTS

Court to Appoint Township Commissioner to Fill Vacant Seat

Pursuant to the First Class Township Code, the Court of Common Pleas of Monroe County will appoint a Commissioner to fill the vacant seat on the Township's Board of Commissioners. The appointed Commissioner will hold office from the date of appointment until January 2, 2018, when a Commissioner elected during the 2017 municipal election will take office.

Applicants must meet all eligibility requirements established by law, including the following minimum qualifications:

- (1) Applicants must be registered to vote in Pocono Township.
- (2) Applicants must have been a resident of Pocono Township continuously for at least one year prior to appointment.
- (3) Applicants must be 18 years of age or older.

All interested applicants should mail or hand deliver a letter of interest and qualifications, a resume, and a list of three references to:

Applications will **not** be accepted via electronic transmission.

All information from applicants must be received **on or before February 29, 2016 by 4:00 p.m.**

Neither applicants nor anyone on their behalf is permitted to contact any of the Judges directly.

After the application deadline closes, a panel of Judges of the Court will review all applications and interview selected applicants before voting on the appointment. Applicants must be available for an interview during the afternoon or evening of March 2, 3, or 4, 2016. The date for interviews will be established once the Court's March 2016 trial term is set. Applicants selected for an interview will be notified during the afternoon of March 1, 2016. The appointment will be announced on or before March 8, 2016.
