Pocono Township Sewer Emergency Operation Manual- J. Belvin explained the EAP was ready for posting and thanked Mike Gable, Twp. Engineer and Patrick Briegel for their excellent work. J. Belvin made a motion, seconded by C. Kilby, to approve and post on Previstar, Pocono Township's Sewer Emergency Operation Manual.

POCONO TOWNSHIP COMMISSIONERS' SEWER MEETING, 01/07/2019 POCONO SEWER EMERGENCY OPERATION MANUAL CONT:

G. Lastowski opened the meeting to public comment. Ellen Gnandt, Twp. Resident, questioned what was Previstar and if it would be available to the public. J. Belvin explained Previstar is the PEMA emergency management database and is available to users. Roll call vote: R. Wielebinski, yes; G. Lastowski, yes; C. Kilby, yes; and J. Belvin, yes. Motion carried.

<u>Pocono Township Continuity of Operations Plan for sewer system</u> - J. Belvin noted the Township does not have a Continuity of Operation Plan for the sewer system.

J. Belvin made a motion, seconded by G. Lastowski, to authorize Patrick Briegel, Boucher & James, Inc., and Commissioner J. Belvin to develop Pocono Township's Continuity of Operations Plan for the waste water treatment system. Ellen Gnandt, Twp. Resident, questioned if a former manager had worked on this. J. Belvin noted they were working on the EAP. Roll call vote: R. Wielebinski, yes; G. Lastowski, yes; C. Kilby, yes; and J. Belvin, yes. Motion carried.

ADMINISTRATION:

Tobyhanna Update - D. Asure, Twp. Manager noted a work session is scheduled for Wednesday, 01/09/2019 at 5:00 p.m., with Tobyhanna Township.

<u>Verizon and Weis Market Update</u> - L. DeVito, Twp. Solicitor, explained Verizon is requesting to hookup to the Township's sewer line in the Township easement in the Weis Market parking lot. Discussion followed. L. DeVito, Twp. Solicitor, noted he is waiting for Verizon's attorney to contact him.

345 Scotrun Avenue - request for reimbursement of tapping fee and permit fees - Steve Pojedinec represented the Donahues. He explained they originally purchased 345 Scotrun Avenue but the deed was not recorded and they did not know at the time that the property was required to connect to the sewer system. S. Pojedinec (Pocono Prime Rentals) agreed to pay the tapping fees for the Donahue, but Mr. Donahue recently passed away. He is requesting the fees be returned to him. Discussion followed on tracking properties are mandated to connect but have not. P. Tripus noted Permit Manager is used to track current and future sewer users.

C. Kilby made a motion, seconded by J. Lastowski, to grant the request to return the tapping and permit fees for sewer connection to Pocono Prime Rentals for 345 Scotrun Avenue in the amount of \$2,689.00. R. Wielebinski noted the property is past the discount rate and the future hookup will be at the full rate for connection. Roll call vote: R. Wielebinski, yes; G. Lastowski, yes; C. Kilby, yes; and J. Belvin, yes. Motion carried.

ENGINEER/SEWER CONSULTANT:

<u>Status Report on Sewer Redesign</u> - J. Tresslar, Twp. Engineer, noted it is complete except for the fencing at Valve Station #1.

Route 611 Sewer Line Relocation Work Update - J. Tresslar, Twp. Engineer, explained due to differences in the original RKR Hess plans, a survey is required. He noted with an accurate survey, the bypass may not be required. Discussion followed on the PennDot reimbursement to the Township for costs incurred.

Sanofi Sanitary Sewer Easement- No report

Pump Station #5 enclosure - was installed 01/04/2019 and is working.

BCRA to develop Valve Station #2 Action Plan - J. Tresslar, Twp. Engineer, noted it is in the EAP. P. Briegel explained they will meet with BCRA to discuss additional information.

BCRA access to SCADA System - P. Briegel, Sewer Consultant, noted BCRA will not tie into the SCADA System.

ACT 537 - J. Tresslar, Twp. Engineer, explained he is waiting for guidance from DEP.

<u>USIC Locating Services, LLC</u> - J. Tresslar, Twp. Engineer, explained after review by P. Briegel and Mike Gable, USIC Locating Services, LLC was recommended. Discussion followed. R. Wielebinski requested additional time to review. No action taken.

<u>Leeward Construction - bypass work at Brookdale</u> - Part of the bypass project.

<u>Fencing</u> - L. DeVito, Twp. Solicitor explained the Stroud Township fencing Ordinance was recommended for approval by Stroud Township's Planning Commission on 11/28/2018.
