Wielebinski, to approve the quote from Pumping Services, Inc to conduct a bypass test at Pump Station #5 in the amount of \$3,865.16 contingent upon solicitor review as recommended by Patrick Briegel and Boucher & James. #### COMMISSIONERS:

Commissioner Lastowski reported that the Board is discussing the possibility of reducing the user fees. The Board must consider the amount of money necessary to have to pay off debts, possibly consider expanding the service area, necessary repairs and maintenance on the system and capital purchases.

#### SEWER CONSULTANT REPORT:

<u>Update - expanding service area</u> - no report

<u>Update - Deferred property and properties with no laterals -</u> It was discussed that a work session with the Board will be necessary to discuss the properties on the deferral list as well as the properties that may not have a lateral. Projects are ongoing such as camera inspections, etc to find solutions to these properties. Dates will be circulated to the Board for their consideration.

<u>Amber Inn</u>- Discussion took place on the request from the owner to pay \$2500 per EDU versus \$3,750. The Board requested that the sewer consultant provide as much documentation as possible for discussion at the next Board of Commissioners meeting and the next sewer meeting.

#### TOWNSHIP SOLICITOR:

<u>Baymont Hotel and Suites connection</u> – L. DeVito, township solicitor reported that the hearing was held on October 1, 2019. The township presented its case and we now await the decision of the court.

<u>Tobyhanna/Kalahari</u> Data is being reviewed as it pertains to volume, the mass loading component (strength of waste) and where this puts Pocono Township as far as capacity and responsibility to the BCRA Waste Water Treatment Plant.

<u>Gateway Equities</u> – As instructed by the Board a lawsuit for tapping fees and user fees will be filed by the end of the end of the week.

#### **PUBLIC COMMNENT:**

Naseer Chohan, Business owner at corner of 611 and 715 spoke to the board concerning his reduced water usage due to competition within the township. He is requesting reduction in EDU's. Discussion took place on the number of uses on the property, the mandatory number of EDU's required by the governing resolution for each use and if there is anything in the resolution that would allow this request to be granted based on water use. Patrick Briegel was asked to look into this.
