COMMISSIONERS COMMENTS

Jerry Lastowski, Vice President reported:

Pre-construction meeting was held with Kalahari Resort, concerning the sewer line construction and temporary closure of Rt. 314. T. Felver expressed concern the closure of Rt. 314 may impact emergency services for Pocono Manor and area neighbors.

HJP Park Board – J. Lastowski visited the HJP regional park on Golden Slipper Road, Bartonsville, and has questions concerning the progress in the Park. He will request Harold Ernsberger to present an overview of the project to the Board at the 06/02/2014 meeting. Discussion followed.

Pocono Township Volunteer Fire Company Meeting - The board concurred to hold a public meeting on at 6:00 p.m., 06/02/2014, at the Pocono Township Fire Company Building.

Gregg Schuster, Pocono Township's new manager will start on 06/02/2014. The Board thanked interim Administrator, Frank Froio, for his work.

R. Wielebinski and J. Lastowski attended a meeting on 05/13/2014, held by the Pocono Township Business Owners concerning the new sign ordinance.

Several board members took at tour of the new NCC Campus on 05/15/2014.

Brad Wise, Commissioner, reported:

A meeting was held 05/09/2014 to discuss Pump Stations and Valves stations operation and maintenance - and the possibility of BCRA providing billing and collection services for the Township.

A meeting was held on 05/09/2014 with MCCD to discuss Pocono Township's NPDES Permit renewal for the sewer project.

A meeting was held with the owner of the Benninger Insurance Property concerning damage to the property during sewer construction.

Jim Purtil, questioned the repair to the damage section of line. Leo DeVito explained the Township has been working to resolve the issue through the court system. In the meantime the Township must move forward with the repair before the case is resolved.

The Township has contracted with RKR Hess to review the proposed Route 611 improvement project from Scotrun to Swiftwater. The proposed Plan calls for the moving sections of the sewer line and manholes in the area. Jennifer Wise-Werkheiser, requested the letters concerning the Rt. 611 project be posted on the website.

Underground Storage Tanks - B. Wise noted the Township is reviewing the procedures for monitoring the tanks. F. Froio noted the State Inspection found one of the sensors has failed on a tank. He obtained a price quote from Francis Smith for \$5,300.00 for new sensors and control system. Discussion followed on additional quotes and determination of when replacement tanks will be necessary. F. Froio will obtain the quotes.

Emil Paletta, questioned signage on a tractor trailer along Sullivan Trail. J. Lastowski noted the Township is working hard to address the signage problems in the Township.

EMERGENCY SERVICES REPORTS

Pocono Township Police Chief Kent Werkheiser - reviewed his report with the Board. 300 incidents were handled. The Department has been involved in an Aggressive Driving Program which receives a 90% reimbursement.
