PUBLIC WORKS DIRECTOR

General update was given regarding the status of current projects.

R. Wielebinski made a motion, seconded by J. Lastowski, to award a bid for the 2023 Sanitary Sewer Manhole Rehabilitation Project in the amount of \$36,795.00 to PIM Corporation. Discussion to confirm the lowest bid was vetted appropriately. All in favor. Motion carried.

Discussion regarding pilot program for hydrogen sulfide (H2S) control as alternative to use of Bioxide. Stated the Township believes this alternative is more cost-effective than Bioxide and would like to explore pilot. Cost is approximately \$8,500 for a two-week trial. This is to address degradation in the sewer lines. J. Belvin asked how much oxygen would be stored, as it may require the Township to report to the County.

R. Wielebinski made a motion, seconded by J. Lastowski, to approve a pilot program in the amount of \$8,500 to mitigate H2S in the Township sewer lines. All in favor. Motion carried.

 Discussion and possible action regarding request of TL Realty for rescinding of accrued user fees on 122 Barton Circle, due to the property being uninhabitable since December of 2016. Property in question was uninhabitable since 2016 due to a fire. TL Realty recently purchased this property at tax sale and was unaware of the lien charges. P. Briegel made a recommendation to rescind the portion of balance beginning when the property was uninhabitable, with the property owner remaining responsible for the period of time prior to the fire. Discussion regarding the rescinding of fees.

R. Wielebinski made a motion, seconded by J. Belvin, to rescind the user fee balance for the portion of fees incurred since the fire, to include attorney fees/costs, and prepare a resolution for passage. E. Gnandt asked for clarification. All in favor. Motion carried.
