The regular meeting of the Pocono Township Board of Commissioners was held on October 18, 2023 and was opened by President Rich Wielebinski at 6:32 p.m. followed by the Pledge of Allegiance.

R. Wielebinski made a motion, seconded by J. Belvin, to execute a sales order agreement with Edmunds GovTech and authorize an ARPA expenditure in the amount of \$37,000 for local government accounting software. Discussion about Edmunds GovTech versus QuickBooks. All in favor. Motion carried.

R. Wielebinski made a motion, seconded by J. Belvin, to amend the agenda for execution of an agreement of sale. All in favor. Motion carried.

R. Wielebinski made a motion, seconded by J. Belvin, to authorize execution of an agreement of sale by the President and Township Secretary between Pocono Township, Northampton Community College and the NCC Foundation for the purchase of the old campus located at 205 Old Mill Road and to submit to the sellers. Clarification of \$2,920,000 purchase price. No public comment. J. Lastowski stated it was a shame the Township could not get PEC. All in favor. Motion carried.

Will pass ordinance language soon.
