Pocono Township Board of Commissioners Regular Meeting Minutes November 6, 2023 | 6:16 p.m.

The regular meeting of the Pocono Township Board of Commissioners was held on November 6, 2023 and was opened by President Rich Wielebinski at 6:16 p.m. followed by the Pledge of Allegiance.

Roll Call: Jerrod Belvin, present; Ellen Gnandt, present; Jerry Lastowski, present; Keith Meeker, present; and Rich Wielebinski, present.

Public Comment

Lawrence Lippert (181 Black Cherry Lane) – Has lived at his home for 36 years. Over last seven years, newer neighbors have begun shooting their guns nonstop. Stated shooting has been nonstop and represents a constant disturbance.

- An executive session was held on Thursday 11/2 to discuss personnel matters and potential real estate acquisition.

Hearings

R. Wielebinski made a motion, seconded by J. Belvin, to open a public hearing for consideration of Ordinance 2023-07 Amending SALDO Section 390-38 and Establishing Traffic Signalization Requirements. All in favor. Motion carried.

L. DeVito stated there has been much conversation about new developments necessitating a new traffic signal or substantial signalization improvements. Discussion that the cost of the ongoing maintenance should be borne by the developer. Ordinance tonight provides that a developer shall cover the maintenance costs for a new traffic signal. No public comment.

R. Wielebinski made a motion, seconded by J. Belvin, to close the public hearing. All in favor. Motion carried.

R. Wielebinski made a motion, seconded by J. Belvin, to pass Ordinance 2023-07 Amending SALDO Chapter 390; Amending Article V Performance Guarantees and Open Land, Section 390-38 Continued Ownership and Maintenance Improvements; and Establishing Traffic Signalization Responsibilities and Repealing All Ordinances or Parts of Ordinances Inconsistent Herewith. All in favor. Motion carried.

Presentations

Presentation of Township 2022 Audit – Jeff Weiss, Zelenkofske Axelrod LLC.

Rachel Gougher presented as the auditor who completed the Township audit. Thanked Township staff for work to prepare all reviewed materials for the audit. Reviewed basis upon which the audit was conducted. Reviewed overall audit provisions.

- E. Gnandt asked questions, including details included on page 14 of the audit. She stated she believed there was a typo regarding restricted cash. R. Gougher provided clarification. E. Gnandt asked about loss to municipal police pension and asked whether the auditor felt this was typical.
- <u>Presentation of Architectural Plans for Proposed New Municipal Complex</u> Matthew McQuaide, Kimmel-Bogrette
 - M. McQuaide provided an overview of proposed plans for the former Northampton Community College campus on Old Mill Road.
- Vassallo Estate Subdivision Plan Request for extension of time for plan recordation.

Jerry Hanna, attorney for the applicant, presented on behalf of the applicant. Discussed the complexity of the property and need for an extension to allow for plan recordation. E. Gnandt expressed concern about the granting of extensions and need for enforcing the Township's standards. Further discussion about conditional approval extensions.

R. Wielebinski made a motion, seconded by J. Lastowski, to grant extension of time to January 31, 2024. All in favor. Motion carried.

Resolutions

Resolution 2023-30 — Motion to pass Resolution 2023-30 Granting Conditional Approval for the Grossi Major Subdivision Plan.

Applicant's engineer provided a recap of the proposed plan. The wetland buffer was the main point of contention the last time. The septic system has been resized for a three-bedroom system to remove the secondary septic area out of the wetland buffer. Reviewed overall waivers being requested.

The Board recessed the meeting for an executive session.

Discussion regarding the resolution as prepared needing to have 365-10.I.(6)(b) removed.

R. Wielebinski made a motion, seconded by E. Gnandt, to pass Resolution 2023-30 Granting Conditional Approval for the Grossi Major Subdivision Plan subject to changes made removing SMO Section 365-10-5-(6)(2). Roll call: J. Belvin, nay; E. Gnandt, yay; J. Lastowski, yay; K. Meeker, nay; R. Wielebinski, yay. Motion carried.

Meeker, to approve a construction escrow reduction for Cherry Lane Development Partners in the amount of \$686,102.65, as reviewed and approved by the Township engineer, conditioned on the receipt of a standby letter of credit from Wawa, Inc. in the amount of \$686,102.65 and review/approval by the Township solicitor. Discussion regarding clarification. All in favor. Motion carried.

R. Wielebinski made a motion, seconded by J. Belvin, to formally commit \$535,000 appropriated in the 2023 Township Budget to be used solely for the purpose of new municipal complex debt service and renovation costs. All in favor. Motion carried.

Motion to approve an easement agreement with the Brodhead Creek Regional Authority for the relocation of a public water line along the property line of TLC Park, as required by the PennDOT SR 715 project and reviewed by the Township engineer and professional staff, and to authorize the (Vice) Chair of the Board of Commissioners as signatory.

This will be delayed until the second meeting in November.

R. Wielebinski made a motion, seconded by J. Lastowski, to amend the agenda for advertising the sale of dump trucks on Municibid. No comment. All in favor. Motion carried.

R. Wielebinski made a motion, seconded by J. Belvin, to place three dump trucks on Municibid for bidding purposes and to authorize manager or public works director to award to the highest bidder. E. Gnandt asked the age of the trucks. No public comment. All in favor. Motion carried.
