Pocono Township Board of Commissioners Regular Meeting Minutes January 16, 2024 | 6:01 p.m.

The regular meeting of the Pocono Township Board of Commissioners was held on January 16, 2024 and was opened by President Rich Wielebinski at 6:01 p.m. followed by the Pledge of Allegiance.

Roll Call: Jerrod Belvin, present; Ellen Gnandt, present; Natasha Leap, present via Zoom; Mike Velardi, present via Zoom; and Rich Wielebinski, present.

Public Comment

Heather Snell (Resident) – Expressed concern about a January 4 incident where she was attacked by a dog on Tara Drive. Stated her dad was also attacked on the same street prior by another dog. Concerned about regulations to protect the public from dog attacks. Expressed concerns about funding for the Police Department and the way she felt the incident was handled.

Joshua Knapp (Resident) – Expressed concerns regarding the environmental impacts of a proposed Warner Road warehouse.

All in favor. Motion carried.

Gnandt, to approve Construction Release No. 12 for the Trapasso Hotel Land Development Project in the amount of \$97,660.33 as recommended by the Township Engineer in a letter dated January 10, 2024.
